Awareness of
Acts, Rules &
Regulations

A lot of Acts and Regulations have been passed but most of these legislations remain widely unknown to the general population at large, thus defeating the whole purpose of passing one in the first place. It is very important for the people to be fully aware and informed of such Acts and Regulations in order to exercise their rights and responsibilities.

Passing of **Budget**

The Constitution specifies different procedures for Submission to be made by the approval of the annual budget and the Budget Legislative Committee Bill. However, in general parlance, the two are seen to be the same which there has been a conflict between the two Houses. There is the need to reconcile either the procedure or the definition.

Proposed Resolution

The National Council seeks the advice of the Supreme Court in the interpretation of the conflicting clauses of the Constitution.

C.

Constituency **Development** Grant

The National Council has passed the 2008-2009 Budget in its first session but objected to state financing of political parties and Constituency Development Grant (CDG). The government has withdrawn the proposal for state financing of political parties but the status of CDG is not clear.

D.

Local Government **Election** Campaign Fund

During the last Parliamentary joint-sitting, the National Council argued that the local government elections should be funded by the government. But Parliament ruled against it. Besides, it also fixed a limit on the permissible private campaigning fund for aspiring candidates who wished to contest in the forthcoming local government elections.

This, however, generated concerns that if candidates were allowed to campaign with their own funds, it would be impossible to ascertain the expenditure made. This would pave way for money-power to influence elections. In order to avoid unnecessary problems, it would be better if no private campaigning fund is permitted for the upcoming local government elections.

E.

Excess land

The National Land Cadastral Survey had required people of all *dzongkhags* to pay for excess land. While payment is being withheld in many *dzongkhags*, the people of eight *dzongkhags* had already either paid for the excess land or surrendered them to the government.

The National Council calls upon the National Land Commission to enable farmers of the eight *dzongkhags* of Haa, Gasa, Lhuentse, Paro, Samdrupjongkhar, Trashiyangtse, Punakha and Wangduephodrang to be allowed to cultivate excess land surrendered to the government until His Majesty the King issues a royal command after the cadastral land survey is completed.

F. Land Compensation Land acquired by the government for public purposes are given land substitute or cash compensation. Sometimes, substitutes may be equal in area to the ones taken over by the government. But the ones taken over may be tilled and cultivated over the years while substitutes may be fallow lands. Thus, the cost of labour, fencing etc. needs to be built into the land substitute and compensation scheme.

G.

Human-Wildlife Conflict Depredation of crops by wild animals, particularly wild boar and elephants has resulted in huge loss of crops in almost all parts of the country. Dealing with wildlife menace has become drudgery to the lives of rural communities.

Besides crops, wild animals also inflict damage to livestock particularly in highland communities. These communities depend entirely on livestock for livelihood. Submissions to be made by Hon'ble Members from:

On the one hand, national and international laws 8. Wangduephodrang protect most of these wild animals. On the other hand, subsistence food security of both highland and lowland communities are threatened by protected animal species.

Proposed Resolution

That the National Council calls upon the Department of Forest, Ministry of Agriculture for the purpose of ensuring the food security of farmers to:

- i. enforce Section 23.b of Forest & Nature Conservation Act, 1995 and issue special permits for taking any animal for the 'purposes of culling or control,
- ii. examine the resolution of the 86th session of the National Assembly that limits 'farmers to shoot and kill wild animals encroaching standing crop fields within 200 metres of the boundary' until the issue of wild boar depredation of crops has been adequately addressed; and
- iii. make adequate compensations to farmers for heavy crop losses to wild animals or for livestock killed by predators if their food security is threatened.

H. Impact of Mining on **Environment** There are lots of mining activities in different dzongkhags. Although mining operations benefit the country economically, the people are concerned that improper exploration of mines cause adverse effects on the environment.

I. Zhabto-Lemi The requirement for labour contribution by Submissions to be made by communities to build or maintain community Hon'ble Members from: infrastructure has become a disincentive for the 1. Trashigang people living in the villages. There is no fixed 2. number of days that a household is required to contribute labour. People's precious time required for subsistence farming and other livelihood activities is taken up by fulfilling labour

J. National Minimum Wage

Labour has become scarce in villages and its value has correspondingly increased. However, the National Minimum Wage Rate has been only Nu.100 a day for more than a decade. For most villagers, wages earned from contributing labour for developmental works has been a major source of cash income. The current wage rate is no longer realistic, especially in the context of rising standard of living.

Proposed Resolution

That the National Council calls upon the government to consider increasing the national daily wage rate, as soon as possible, to enable people in lower income brackets to adjust with the rising cost of living.

K. Appointment of Caretaker for Gewog Centre Every *gewog* has a gewog centre consisting of the office of local governments. The gewog office is usually located away from the main village. They are vulnerable to theft and vandalism.

Each *chiwog tshogpa* is assisted by one or more *chipons* in addition to *chusungpas* and *mesungpas*.

Duties of a *chipon* require him/her to be always on 1. Pemagatshel the move within the designated village mostly running errands for other GYT Members even to the 3. Lhuentse extent of foregoing his/her own household 4. Trashigang activities. These services, however, are currently rendered free. Considering the difficulty and importance of the job of a chipon, it is only fair that his/her services be remunerated appropriately.

Wages & Remuneration for Gewog **Officials**

Gups and Mangmis travel in their gewogs for Submissions to be made by officials purposes. Their works are not limited to office premise alone. They also often stay overnight in villages depending on the distance from the gewog centre or on the nature of assignments they have to undertake. But they are not entitled to travelling allowances contrary to the Gewog Administrative Officer or other civil servants in the gewogs.

Thrue be reinstated as **Public Holiday** The festival of thrue or Blessed Rainy Day, which has been celebrated for hundred of years, has been removed from the list of national holidays. It is not just a holiday but an important cultural and spiritual heritage. Although it is officially not a holiday, families and communities continue to observe it. Government and public institutions function on this day but most staff take leave to be with their families.

Role of Party Workers in Governance

The people of some *dzongkhags* are concerned about the role of political party *tshogpas* in the *gewog* activities. In some *gewogs*, party *tshogpas* seem to be interfering in the implementation of the development activities thereby creating some confusion. At the center level as well, the appointment of 4 party workers in the Cabinet Secretariat appears to be unlawful while also violating the spirit of the Constitution to maintain an independent and apolitical civil service.

Farm Road **Issues**

The farm roads constructed over the years have benefited rural communities. However, part of the arrangement of farm road construction is that communities must maintain them. But most farm roads are washed away by landslides or blocked by falling boulders and mudslides every year. Labour obligation required to clear the roads and maintain them is very heavy, particularly, during rainy season when farm works are at their peak. Currently, approved budget of Nu. 1.3 m/km of farm road is inadequate to cover essential works like soling and drainage. It leads to fast deterioration of roads, and the road become unusable. Due to acute shortage of manpower, the village communities are unable to contribute labour for farm road maintenance.

- include maintenance of farm roads and power tiller iii. tracks as part of the work awarded on contract basis;
- provide daily wage for labour contribution as part of iv. Zhabto-lemi or hand over farm road construction and maintenance to the Department of Roads.
