#### POLICY REVIEW ISSUES – 1

# a. Issues related to restoration and renovation of sacred artefacts

Choeten (stupa) vandalism has become an issue of national concern. Hundreds of *choetens* are desecrated and vandalized every year. The instances of robbery keep increasing as per the record maintained by the Royal Bhutan Police. Some vandalized *choetens* are restored by private individuals or through fund collected from the devoted local communities. However, most of the vandalized *choetens* remain desecrated without restoration mainly due to lack of funds.

Although the local communities are willing to contribute labour and other locally available resources in restoring the *choetens*, they would like the government to provide funds for *Zungs*. The Social & Cultural Affairs Committee will submit a report on the extent of *choeten* vandalism to the National Council and seek its directives in addressing the issue.

#### POLICY REVIEW ISSUES – 2

## a. Presentation of follow-up report on Impact Assessment of Mining Activities

The Natural Resources & Environment Committee (NREC) had followed-up with relevant ministries and agencies, such as National Environment Commission (NEC) Secretariat, Department of Revenue & Customs (DRC) under Ministry of Finance, and Ministry of Economic Affairs (MoEA), on the implementation status of the 10<sup>th</sup> Session resolution on the impact assessment of mining activities in Bhutan.

The resolution is at varying stages of its implementation and it will be reported to the National Council for deliberations.

# b. Issues on the legality of banning of mining activities by Local Government (LG) within their geographical jurisdiction.

Instances were reported where Dzongkhag Tshogdu had banned mining activities in certain areas of Dzongkhag's geographical jurisdiction. This had created confusions among different agencies and stakeholders as to whether a Local Government has legal authority to prohibit mining in certain areas.

The Natural Resources & Environment Committee (NREC) will be submitting its view for further consideration of the House.

# b. Review report on performance audit of Constituency Development Grant (CDG)

Constituency Development Grant (CDG) with a provision of Nu.2 million per constituency per year was implemented by the previous government during its tenure from 2008-2013. It was implemented despite the National Council's strong objection to the scheme. In early 2012, the Royal Audit Authority (RAA) had conducted a performance audit on CDG activities. The Good Governance Committee has reviewed the Royal Audit Authority's performance audit report. Its findings and proposed recommendations will be presented to the House for deliberation.
